- 4. I accept full responsibility for the care and return of the equipment in a clean condition and agree to reimburse Adventure Consultants Ltd for any loss or damage other than reasonable wear resulting from use.
- 5. I accept full responsibility for any group equipment that is in my use or care, and agree to reimburse Adventure Consultants Ltd for any loss or damage other than reasonable wear resulting from use. (this includes but is not limited to items such as climbing ropes, tents etc).
- 6. I agree to pay the full daily rate for any items not returned in the period charged for on this contract, and that breakdowns resulting from misuse shall in no way shorten the period of hire.
- 7. INJURY OR DAMAGE TO HIRER OR THIRD PERSONS OR PROPERTY The hirer shall not have any claim against the owner, Adventure Consultants Ltd. for loss or damage suffered by the hirer as a result of the hirer's use of the equipment and further the hirer will indemnify the owner against any claim made against the owner by a third person or other losses arising out of the use of the equipment by the hirer.
